### PROCEDURE

### "SUBMISSION OF APPLICATION AND ALLOTMENT OF USER ID AND PASSWORD Applications should be submitted only online through AICTE web portal www.aicte-india.org on payment of Rs. 5000/- through the payment gateway

### REMITTANCE OF PROCESSING FEE

The Processing fee should be paid through AICTE payment Gateway through Corporate internet banking only.

### PROCESSING OF APPLICATIONS.

- Evaluation of applications at Regional Office by the Scrutiny Committee(s) constituted through automated selection process of AICTE Web portal.
- Based on Scrutiny Committee recommendations, deficiencies or otherwise to be communicated to the applicant institution through AICTE web portal.
- Deficiencies to be complied with within 15 days from the date of posting the deficiencies in
- The applicant institutions, if aggrieved by the decision of AICTE at Scrutiny stage may submit an appeal, which will be considered by a Standing Appeal Committee, which may recommend for re-scrutiny of applications.
- The applicants recommended for Expert Committee Visit by the Scrutiny Committee, shall be communicated the date of Expert Committee Visit through Web portal.
- Expert Committees constituted through automated selection process of AICTE Web portal, will visit the applicant institution and upload the document through the web portal of the applicant institution or else scan the same to the email ID of Regional Office.
- The reports of of Scrutiny Committee /Expert Visiting Committee to be placed before the
- The Regional Office will scan the Regional Committee Reports and upload and evaluate the same through the AICTE web portal.
- The cases decided by the Executive Committee have to submit Money Deposit (online) and affidavit<sup>2</sup> for further processing at AICTE, New Delhi.
- The applicant institutions, if aggrieved by the decision of AICTE after Expert Committee Visit may submit an appeal, which will be considered by a Standing Appeal Committee, which may recommend for Expert Committee Visit.

- Change of name of the institution
- Second Shift Programmes
- Part Time Programmes

### PROCEDURE

## > SUBMISSION OF APPLICATION

Applications should be submitted only online through AICTE web portal www.aicte-india.org

### USER ID AND PASSWORD

The existing institutions may use the same user ID and Password allotted by AICTE. If the institution has misplaced / forgotten the password, it may obtain another user ID by paying an additional amount of Rs. 5000/- through the payment gateway.

## REMITTANCE OF PROCESSING FEE

The Processing fee should be paid through AICTE payment Gateway through Corporate internet banking only.

### PROCESSING OF APPLICATIONS

- Approvals for the above purpose will be granted by AICTE based on self disclosure and submission of affidavit attested by First Class Judicial Magistrate / Notary / Oath Commissioner. Since the approval is granted based on the information provided by the applicant institutions, there will be no provision for appeal.
- Processing of applications through Scrutiny Committees done only in case of change of name, reduction in intake, closure of course(s) / programme(s).
